| <p>BARSC and British Schoolgirls.</p> <p>The highlighted concerns over a possible causal link between binding settings and knee/lower leg injuries were noted. Whilst the responsibility for the selection and preparation of equipment lies with the racer, it was recognised that coaches could exert an influence. It was agreed that the Chairman should bring these concerns to the attention of the Alpine Exec with a view to heightening awareness amongst coaches.</p> <p><b>5.3 Snowsport England</b> It was agreed that a minimum BASS point criterion of 400 points should be applied to FIS Restricted License applications. Chairman to raise with AlpEx</p> <p><b>5.4 Snowsport Scotland</b> As a result of issues with over-subscription of British FIS races, ROCs were reminded that they needed to inform Dick Taplin of the quotas they wished to apply to the host nation of their event. | <p><b><u>7.1 Report by GBR FIS Commissioner</u></b></p> <p>ML reported that CAN, AUS and GBR have proposed that active FIS TDs be visited during an assignment by an assessor to ensure TD training had been effective.</p> <p>SB requested that ML proposes to FIS that 602.2.3 and 602.2.4 are adhered to.</p> <p>Concern was expressed that the TD appointed to the British Champs did not speak English, which made Jury communications extremely difficult. Concerns were also expressed about TDs appointed from the host resort as again they tended to make little contact with British team members.</p> <p>ML was asked to try to arrange that TDs for British FIS events should be able to communicate with the Jury in English and are appointed from outside the resort.</p> <p><b><u>7.2 On Line Homologation Documentation</u></b></p> <p>MB requested that Homologation Documents were made available on line for viewing prior to attending the race.
